PLEASE NOTE: JUNE TUITION

Please be aware that June tuition for the Before and/or After School programs will remain the same amount and will only cover until the last day of school. Our tuition is divided up into 10 equal payments and we do not charge additional fees for months including school vacations, half days or teacher in-service days.

Hours

Before School: 7:00am-8:20am (Forest, Farley and Mulready only)

After School: Dismissal until 6:00pm

After School CHAPS is open upon dismissal until 6:00pm on half-days and from 7:00am-6:00pm during vacation days and teacher in-service/no school days.

****NEW** Technology Policy**

Effective the start of school, there will be a new technology policy. Children will NO LONGER be allowed to use electronics during Before School CHAPS at ANY SITE. Parents of children attending After School CHAPS, will be asked to sign off on the CHAPS Technology Policy before using a device during CHAPS hours.

Procare



CHAPS uses a software system called Procare. For this system it is helpful to have a photo of parents (or other frequent pick-ups) as well as your child. We ask that each family please send (via email if possible) a family photo (or individual photos) so we can upload them into Procare. These photos will not be shared or put on display. They are being used solely for the security of your child while at chaps.

Procare is also used for signing children in and out of the program. This software recognize authorized users by their fingerprint scan. You will be asked to register your fingerprint the first time you pick up or drop off.
